1. Introduction: what a publication scheme is and why it has been developed

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this we have produced a publication scheme, setting out:

- The classes of information which we publish or intend to publish;
- The manner in which the information will be published; and
- Whether the information is available free of charge or on payment.

The scheme covers information already published and information, which is to be published in the future. All information in our publication scheme is available on our website.

Some information, which we hold, may not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

2. Aims and Objectives

At Bushmead Primary School we believe that every child matters. To achieve this we:

- Promote positive partnerships with parents and the community
- Develop confident, independent learners, and successful, healthy and responsible citizens
- Foster trust, support, consideration and respect for all
- Have high expectations, strive for excellence and enable the children to achieve their potential
- Promote equal opportunities for all children to develop skills and achieve success
- Provide a challenging, stimulating, safe and secure environment
- Work together as a team (children, staff, Governors, families and the community)



- Provide enjoyable learning opportunities to promote learning through first-hand experience
- Encourage children to develop their independence and become creative thinkers. This publication scheme is a means of showing how we are pursuing these aims.

3. Categories of information published

The publication scheme guides you to information which we currently publish (or have recently published) or which we will publish in the future. This is split into categories of information known as 'classes'. These are contained in section 6 of this scheme.

The classes of information that we undertake to make available are organised into three broad topic areas:

- Information relating to the Governing Body information published in Governing Body documents.
- *Pupils and Curriculum* information about policies that relate to pupils and the school curriculum.
- School Policies and other information related to the school information about policies that relate to the school in general.
